SAC Warranty

Did you know?

- All SAC engine rebuilds and conversions carry a six month/6 000 km warranty. (Which ever comes first)
- Services and Dyna tunes are warranted for 2 000 km or six months. (Which ever comes first)
- Water leaks, when applicable are warranted for 2 000 km or six months.

 (Which ever comes first)
- Electrical repairs are warranted for 2 000 km or six months (Which ever comes first) Electrical components are not warranted at all.
- "Oil leak" repairs are warranted for 2 000 km or six months (Which ever comes first) and then only if repaired and charged for.
- Repairs not listed above are warranted for six months/6 000 km. (Which ever comes first)
- Accessories including exhaust systems, sourced and fitted by SAC are not warranted. SAC however will endeavor to perform a claim against the supplier, should the need arise.

Terms and Conditions

- In order to validate our warranty, your invoices need to be retained and submitted in the event of a claim.
- A comprehensive service history, together with all invoices must be submitted in the event of a claim.
- The manufacturer's warranty conditions must be strictly adhered to in the case of a conversion on a new bike.
- After an engine rebuild, the bike must be serviced and or checked at SAC +/- 1 000 km, max 1 500 km after job completion and thereafter every 6 000 km.
- When an engine conversion has been done by SAC, the bike must be serviced by us every 6 000 km.
- 📢 No other modification may be made to the bike's engine unless authorised by SAC.
- Any similar work not authorised by SAC will invalidate the warranty. SAC will not be liable for the payment of work not authorised by SAC.
- Towing, trailering, bike recovery and bike / vehicle rental is not covered by the Why Worry Warranty.
- The warranty expressly excludes liability for consequential loss or damage, in the event of componential failure or similar.
- The warranty does not extend to include loss and or damage resulting from normal wear and tear and or deterioration arising through usage and age of the bike.
- The warranty will be invalidated if any seals fitted by SAC are broken or tampered with or if the bike is ridden until it stops, despite a warning from a irregular noise and or check light on the dash consol or speedo.
- The SAC warranty expires if the odometer has been tampered with or if the bike has been used for racing or competition purposes in any way.
- This warranty is for your benefit. Use it but don't abuse it, and apply common sense!
